





I am the daughter of Florence Wile-Hodsdon writing to inform you of mom's passing on April 30th. Mom had a long and fond history during the years she worked at Unum. She began her career in 1940, when it was Union Mutual Life Insurance Company. She went out on maternity leave in 1943. She returned to Unum in 1964. The humor here is that she had the longest maternity leave on record for the company! Dave Stanley, V.P. remarked at her retirement party in 1984 "thankfully we didn't have to pay her as we do now."

Mom was a very active Unum retiree and a frequent contributor to your newsletter. One particular article, that I am referring to as I write this is called **REFLECTIONS** by Florence Wile-

Hodsdon, written Jan 8, 2006.*

Mom lived in her beloved home town of Yarmouth until September of 2013, when she moved to Cadigan Lodge at the Highlands in Topsham. Unum Corporate Track Team

Purpose:

The purpose of Unum's Corporate Track Team Program is to promote personal fitness, team-building, working out together and having fun.

Our goal is to have a variety of employees and retirees from throughout the corporation, success fully train and compete together.

Eligibility:

To be eligible for the Unum track team, an employee must work a minimum of 30 hours a week prior to the Nationals. Retirees are eligible after 10 years of employment with Unum.

History:

The Unum track team was established in 1985. The team attended its first nationals in Los Angeles in 1986 and has continued participating in meets here in Maine. The Unum team has won the State of Maine Corporate Track Championship in all but five of the years we have competed in MECTA meets.



Between April and July, Portland based team members have regularly scheduled practices.

Events:

All events are team or relay events with batons being used on most track events. Competitors in the shot put, discus, long jump, high jump, 5k &10k, road races are all scored in 5 year age brackets.

Track events have legs ranging from 100m to 3200m, gender, age, and position.

Plausible 2015 Social Security Cost-Of-Living-Adjustment

Each year, the Social Security cost-of-living adjustment for all beneficiaries is based on the year-over-year average percent change for the third quarter (in the prior year, or 2014/2013) of the consumer price index of "wage and clerical workers". Well, as of May, this comparison stood at +2.1%. If prices hold steady through the period we should all expect a minimum increase of about 1.5% next year. With some moderate gains through September, this increase in the annual "COLA" could increase by as much as +2.5%.

That's the good news. However, one must remember, for those retirees on Social Security who are now age 65 and over (and thus have Medicare as their primary health care provider), there could be a year-on-year increase in the Medicare Part "B" premium which is subtracted from one's monthly Social Security payment. If this happens in January, the net effect would be to subtract from the likely gross increase of 1.5-2.5% in the monthly S.S. benefit next year. Retirement finances may not be excellent, but they still beat the alternative!

Niagara Falls - Worth the Trip!!

This was my first time visiting Niagara Falls, after having heard about it all my life and seeing the Marilyn Monroe/Joseph Cotton film "Niagara" more than once. The 2014 version of Niagara Falls is more inviting than the 1950's film version. I designed the trip so I wouldn't have to do any driving (other than to and from the local transportation center.)

I took a comfortable Concord Trailways bus from Portland, ME to Boston, flew Jet Blue to Buffalo, and used the "Airbus" van service from the Buffalo airport to my hotel. Everything was on time and without a hitch. My suite at the Embassy Suites was clean, comfortable and had a view of the Falls. Having a kitchenette for a 4 night stay is more than convenient, almost essential, as I prefer eating in my room to dining out. Being a vegetarian, I found it surprising that neither the hotel nor the TGI Friday's located in the hotel had even one vegetarian meal on their dinner menus. I found a "coffee shop" called "the Famous" only a block or two away that has veggie burgers and other vegetarian choices...their prices were good and the food excellent.



It is located inside the big Fallsview Casino hotel complex, along with several other restaurants, shops and a food court. They served the best fresh fruit salad I have ever had, anywhere.

The first glimpse of the Falls was from the road before getting to the hotel. The driver stopped and suggested we all get out and take a look, while he had a cigarette! The Falls looked smaller than I had imagined, but we were at a distance and up higher, later after checking in I walked down to the Falls and experienced the constant thundering sounds and the mist from the Horseshoe Falls that rises up thickly and higher than the river and drifts across to the walkway and road that runs alongside the river. Another day I would find time to sit in the sun near enough to hear the Falls and meditate.

The first day I planned to take the "WEGO" bus (\$7.00 for a 24-hour pass) to the Niagara Falls History Museum. I had a map showing three different color bus routes and there were bus stops marked "WEGO" on the streets, with either red



line, blue line or green line designations on the signs. From the map I couldn't tell which way to go to find the right color line, so I asked directions of a valet along the way...he didn't seem to know either but looked on the map and pointed me...in the wrong direction as it turned out! It was a pleasant morning and I like to walk, so I walked a long way, asked directions again of someone who didn't know, and eventually found the right bus stop with a welcoming bench. When I looked before sitting I saw it was covered with large drops of water from the rain the night before. I only had a tissue to dry it, but I did what I could and then sat on my raincoat to wait, whiling away the time by comparing two maps I had acquired to try to figure out where I was and where I was going. I was deep within the maps when the bus pulled up and the friendly driver said "I hate to interrupt you..." and away we went. I was the only one on the bus.

After that first day I was able to understand the WEGO system and take another route to the Butterfly Conservatory.

I walked to the Skylon Tower for some excellent photo opportunities and on the last cold, windy and rainy afternoon enjoyed the National Geographic IMAX Movie depicting the history, myths and miracles of the Falls. I met friendly people all along the way and enjoyed the adventure from start to finish!

Reflections.

The year was 1940. War was spreading throughout Europe, and the United States was providing ships, planes, and other supplies as rapidly as possible to the Allies. Rolland Irish was President of Union Mutual Life Insurance Co., and those in charge of planning deemed it wise to add disability insurance to the thriving life insurance business. The result the purchase of Mass. Accident Ins. Co. Those employees who chose could move to Portland and many did; however, some clerical people preferred to terminate and remain where they were.

In view of this, UM interviewed and hired five locals to train to replace those openings needing filling. I was one of the five – North Yarmouth Academy graduate, enrolled at Northeastern Business College, seventeen years old and green as grass. I was interviewed by Harold Lang, Vice President. One of the requisites was a complete physical exam, something I had never had. Alvin Ottum, MD was the physician. Following the exam, my temp was slightly elevated so this required a return check. Happily all went well and I became a trainee.

We five left by train to Boston in March. Upon arrival, we were housed at the Franklin Square House in Dorchester and from there taxied to and from Kilby St. in Boston to work. As I was not a fast typist, had little or no shorthand experience, I was assigned to the accounting department under the tutelage of a very pleasant and efficient lady.

We returned to Maine in May and were housed on the 4th floor of 440 Congress St. Those connected with the life side of the business were on the 3rd floor with Purchasing, Printing, and Maintenance on the Exchange St. side of the building. Maine National Bank was on the first floor providing easy access for banking. Later we had a credit union with our own employees on the board. South Portland Ship Yard and Bath Iron Works were teeming with activity and employees. It wasn't long before these folks were enrolled in the disability coverage. As you can imagine, this involved a massive amount of clerical work. I, along with two others, was assigned to wait on clients, updating records, verifying payments, diversified and interesting.

The company housed about 300 in the home office building. A mutual company, with agencies throughout most of the country, the actual enrollment was much larger but in the home office there was a feeling of "family." We soon knew everyone, and the women had an organization known as the FUNCHAT CLUB. I am a past-president. We held regular meetings, had a bowling league, - a typical social group.

There was a sense of belonging to, and being part of, something special. On birthdays, a birthday cake was delivered to one's home by Cushman Baking Co., courtesy of the Company. Christmas was a special time - every employee received a small gift. Sales promotions where the high producing agents would be brought in from the field, often included a picnic, various sports events, ending with a dinner and dance.

It was the custom of the larger companies, UM, NETel., the banks, to hire only single women. By December of 1941 the United States became part of the Allies in the battle against the Axis, and, it wasn't long before the practice died a natural death - Married Women Also Needed To Work... This proved to be in my favor as war was declared Dec. 7, 1941, I was married Dec. 25, 1941, and became the first married woman allowed to continue working.

In 1943, I terminated to raise a family, only to return in 1964, finally retiring in 1984. A humorous aside, upon returning, I was told there was a reference to my being on "maternity leave." Dave Stanley, V.P. remarked, "thankfully we didn't have to pay her as we do now."

I have nothing but fond memories of the company and people as I knew them. This is one of the reasons I enjoy HEADLIGHTERS and feel by doing my bit for VALUR I can show my appreciation for the experience.
